**Re:** Posting Requirements - NLRB Settlement Agreement on Information Requested Concerning Ergonomic Issues Related to DBCS & Consolidation of Tour 2 Mail Processing Operations

This is a follow-up to my May 3, 2010 memo in regard to the above-referenced matter. We have had ongoing discussions with the NLRB, Region 5 (Region) concerning the posting requirements of the NLRB Settlement Agreement.

We have been informed by the Region that in light of the large number of facilities where posting must occur, the Postal Service was required to provide the Region a list of the facilities, in advance of posting, it believes meet the requirements for inclusion. The Region provided the APWU with the Postal Service's proposed list (attached) and now requests that the APWU review it and inform the Board whether there are any deletions or additions that we believe should be made to the list. In addition, if the APWU identifies a facility that should be included and is not, we must specify the location of the facility, the type of facility and why the Union believes posting at that location is required by the settlement agreement.

We disagreed with the Region's process for ensuring compliance with the posting notification. We maintained that it should be sufficient for the APWU to monitor compliance with the posting requirement by notifying the Region in the event it discovers Notices were not posted at appropriate facilities. However, given the scope of the posting requirement in this case, the NLRB has determined that it is necessary to establish in advance at which facilities posting must occur. Therefore, the NLRB asked the APWU to conduct a careful and thorough review of the list and to inform them of any discrepancies in advance of posting. We were also informed that because the Union is given the opportunity now to inform the Region of locations that the Union believes should be included, the Region will not entertain objections based on failure to post at an unlisted facility once the posting occurs (with the exception of a posting not occurring in a facility that is included on the final list). However, absent evidence received during the posting period of a problem with the posting at a listed facility, the NLRB will close the case at the end of the posting period.

Although the Union will try to provide comments based on what information we have available, as we explained to the NLRB, we protest in the strongest terms the Region's attempt to shift to the Union the obligation to identify posting locations. *Please be advised that we are still trying to persuade the NLRB to adopt our suggestion.*


### Local Review

In addition, in the event the Postal Service fails to post the required notice in any facility on the final list, my office should be notified as soon as possible, but no later than the end of the posting period.
